

## Babergh & Mid Suffolk District Councils Climate Change Task Force Terms of Reference

1. Title of Task Force	Babergh & Mid Suffolk District Councils (BMSDC)
	Environment & Climate Change Task Force
2. Purpose	The Task Force has been convened in response to climate change and biodiversity motions passed by both Councils in July and September 2019. Its role is to make recommendations to Cabinet(s) on opportunities and actions to protect and improve the environment, both in the way in which the Councils jointly carry out their own operations and initiatives, and through partnership working.  Both Babergh and Mid Suffolk District Councils recognise that there is an urgent need for action. The Task Force will consider how best to embed environmental considerations that support the districts' climate change and biodiversity ambitions into future decision-making, alongside wider social and economic factors.
3. Rationale	The Councils along with Suffolk County Council and other local authorities recognise the need to act decisively to respond to the commitments they have made. One of the first steps must be to ensure that there is clarity about the effects of current operations and to understand where the most potential lies for improvement. This will enable resources to be prioritised to achieve maximum benefit. Further work, beyond the scope and term of this Task Force, will be required with partner organisations to tackle emissions across Suffolk.

10. Outcome	Recommended actions to delivering net zero carbon emissions from BMSDC by 2030 in line with the aspirations for Suffolk and other neighbouring local authorities.  Recommended actions to avoid future biodiversity loss and conserve and enhance existing habitats and species
11. Outline Timescale	<ul> <li>Meetings to cover the issues shown in 9 above commencing October 2019 and completing by the end of March 2020.</li> <li>Presentation to spring Cabinet Meeting for approval.</li> </ul>

The Chairman and Supporting/Lead Officer may choose to set up a sub-group or task and finish group to address specific areas of work. The composition of any such group would be at the respective Chairman's discretion and may involve members outside of the Task Force.

The Chairman and Supporting/ Lead Officer may invite guest speakers and/ or third parties to widen the expertise and advice available to the Task Force as the work of the group dictates.

The Chairman and Supporting/Lead Officer must ensure the Panel adheres to all relevant dates in respect of submitting reports to Cabinet. This will include a date for Cabinet briefing of the draft final report and deadline for submission of the final report to Democratic Services. It will also include submission of the Key Decision Forward Plan Request.
