council services, or around ± 3.62 a week. That's a 2.99% rise, the equivalent of just 11p a week, on our share of the bill.

I think that still represents excellent value for money.

The rest of your bill goes to Suffolk County Council, the Police and Crime Commissioner, town and parish councils.

We recognise these continue to be challenging financial times for everyone, and councils are not immune from this.

All authorities have seen their financial position eroded over many years, mainly due to central government funding failing to keep pace with costs and demand, plus inflationary pressures.

We will have to find extra income and/or savings of £6.7million over the next four years just to continue delivering the services we currently do - services I know you all value a lot.

Despite these challenges, we remain extremely ambitious for our fantastic district.

As well as delivering good quality core council services, our vision for the next three years is to create a resilient, more sustainable future - built on strong communities, a thriving economy, and protecting our environment.

Ultimately, we want Babergh to be a great place to live, to work, to do business and visit.

Testing times call for imagination, innovation and collaboration listening to you about what you think is important and how we can develop sustainable local solutions to local issues. Working together will be so important.

Suffolk is a good police force. It offers value for money to Suffolk communities and I am proud to serve as the county's Police and Crime Commissioner.

This year, officer numbers will reach 1425 – more than has ever been recorded. Some of this investment comes from your council tax, the rest from the government's police uplift programme.

In addition, investment in the control room has resulted in the recruitment of an additional 27 call handlers this year which is having a significant impact. Maintaining a good service costs money and keeping crime levels low in Suffolk is crucial for us all. It cannot be in the county's interest to make cutbacks in our policing capabilities.

I know any increases in taxation are unwelcome, but I can assure you I am doing everything possible to make sure the force spends your hard-earned money as efficiently and effectively as possible and holding the Constabulary to account accordingly.

That said, any organisation should always look for and deliver greater efficiency and increased value -Suffolk Constabulary is no exception, so this work will continue.
