# IMPACT REPORT

# THE FUND

Community Development funding has been established to help support VCFSE groups in Mid Suffolk establish new and innovative projects in the district, particularly where gaps in existing provision are evident.

Funding for Revenue and Capital projects was available, with a portion of funding ringfenced for pre project costs, such as feasibility studies.

The first round of Community Development Funding opened in April 2023, with the outcome announced over the summer.



All applicants are required to submit a Monitoring Form one year after the funding was awarded to their organisation, with outcomes and indicators to show the intended improvements brought about by the funding and how this has been measured.

**OBee CIC** reported the following results from the funding for their project, supervising Volunteers making repairs to the Greenwood Roof.

a group of 87 contributed 936 volunteer days from the period 1/10/2023 - 20/07/2024
